**ROLL CALL**

The secretary called the roll: Anthony Taliani-present; Rick Stoneburner-present; Edward Kissel-present; Joseph Novosat-present; John Nwranski-present.

**MINUTES**

Mr. Stoneburner moved to accept the minutes from the Agenda meeting held on September 3, 2015. Mr. Kissel 2<sup>nd</sup> the motion. Motion passed unanimously.

Mr. Novosat moved to accept the minutes from the Regular meeting held on September 10, 2015. Mr. Nwranski 2<sup>nd</sup> the motion. Motion passed unanimously.

**CITIZENS COMMENTS**

Rachel Shurnia – 323 Bailies Run Road – problem with her water being brownish in color. Has done everything that we have suggested and it is still brownish and would like to know what we will be able to do with the color. Ms. Shurnia advised that when we flush the line it is clear for a day or so than the color comes back to a light brownish.

Mr. Taliani has advised that we have been flushing the line on a regular basis and that she is on a dead end of the water line. Mr. Taliani has advised that we have done testing on the water and the water is okay to drink and use but understands why you would not want to drink a discolored water.

Mr. Taliani has advised that we will work with our engineer and see what we can do about the brownish color in the water. He has instructed our water crew to flush the line on a daily basis and that we will do more testing on the water.

Mrs. Kathleen – it was brought to the board of a concern of a neighbor that is causing a few issues in the neighborhood. They are feeling a little threatened of jesters that this neighbor has made and that if this keeps up with this neighbor they are going to have to move and they do not want to move since they have been in the neighborhood longer.

Mr. Taliani advised for her to speak with the police department and make sure that everything gets reported to them and is on file.

### **RESOLUTIONS – ORDINANCES**

Mr. Nwranski moved to accept the final reading of Ordinance NO. 814 on the contract between East Deer Township and the United Steelworkers for a 4 year contract. Mr. Stoneburner 2<sup>nd</sup> the motion. Motion passed unanimously.

Mr. Taliani went over the updated Ordinance No. 814 of the 2016 Budget. We will keep updating from now till December and will pass the 2016 Budget in December 2015.

Mr. Stoneburner motioned to pass the Resolution 2015-4 authorizing the preparation of the application of replacement of sewer line on Crawford Run Road. Mr. Kissel 2<sup>nd</sup> the motion. Motion passed unanimously.

### **COMMITTEE REPORTS**

Mr. Stoneburner advised that the Edna Alley water line project has been finished by Ron Gillette.

Mr. Stoneburner also wanted the road crew to know what a nice job that they did on the new turn around on Yost Drive.

Mr. Taliani also gave a nice job to the road crew on the reconstruction of the pedestrian bridge on Bailies Run Road.

### **OLD BUSINESS**

Mr. Taliani advised that the new Police Car was done and on its way to us that evening that Police Chief Manchini was picking it up.

Mr. Taliani passed out sheets on the burning regulation from the Allegheny County website for what is allowed to be burnt.

### **NEW BUSINESS**

Mr. Nwranski moved to accept the proposal from MIBS to build a new website for East Deer Township I the amount of no more than \$3500.00 to be paid in installments. Mr. Stoneburner 2<sup>nd</sup> the motion. Motion passed unanimously.

Mr. Taliani brought to the board of a new agreement to look into for next year with PENDOT for the Winter Agreement to doing Actual cost.

Mr. Stoneburner moved to advertise the selling of the 2006 Ford Crown Vic police car with the arrival of the new Police Cruiser. Mr. Kissel 2<sup>nd</sup> the motion. Motion passed unanimously.
