# **BIDS**

# **OLD BUSINESS**

Mr. Taliani is advising that on the Bailies Run Road Water Line Issue he is going to be working with the contractors and that we have an emergency permit and think that we are going to use this as an emergency permit once we get the information from the contractor. Once we get the bid from the contractor we will be able to proceed with the project.

Mr. Taliani advised that on the Yost Drive/Old Murray Hill Strom Drain Issue/ Working with John (Ron Gillett Inc,) to Install Type M Catch Basin To 60 ft 6" SDR and fitting approx. 84ft of 8" SDR and fitting connected to 12' Pre-existing. backfill one foot around with stone. backfill the rest with existing material for the sum of \$10,286.00. Mr. Nwranski Motioned to accept to the bid from Ron Gillet of \$10,286.00. Mr. Kissel 2<sup>nd</sup> the motion. Motioned passed unanimously

# **NEW BUSINESS**

Mr. Taliani announcing of Keystone Communities Program Grant in the amount of \$250,000.00 to complete our Water Tank. Phil is working already with this and the \$50,000.00 that we got last year to start to together what we need to complete and even make a little more minor improvements. Make sure that we Thank Mr. Dermody and Governor Tom Wolfe.

Mr. Taliani also advised that we got a Grant for \$20,000 for Demolition but they are advising that we take down the duplex on Edna and not the Italian Club. He is still trying to work on getting the Italian club taken down.

Mr. Taliani advised that we have 2 summer helpers Josh Biernacki and Sal Stoneburner that are wanting to return this year and a third that applied. Michael Senge. Last year we paid the guys \$8.50, this year I want to pay them a little more that. I am looking at hiring the kids at \$9.00 an hour and if the county kids come in that we hire the pay them to \$10.00 an hour. Mr. Kissel motioned to hire the summer helpers at \$9.00 an hour and if the county kids come in that we hire the pay them to \$10.00 an hour. Mr. Novosat 2<sup>nd</sup> it. Motioned passed unanimously.

Mr. Taliani advised that our 50" craftsman that we bought over 20 years ago "shit the bed" and we went out and got some prices on some zero turns. They decided that they are going to look at around and just go and buy one.

Mr. Taliani advised that we received a letter from ACED requesting the Municipality's participation in Allegheny County' Community Development Block Grant Program and the Home Investment Partnerships program for the next three years July 1, 2018 thru June 30, 2021. Mr. Nwranski motioned for the board to stay with participating in the Allegheny County' Community Development Block Grant Program and the Home Investment Partnerships program for the next three years July 1, 2018 thru June 30, 2021. Mr. Kissel 2nd the motion. Motioned passed unanimously.
