MR. TALIANI CALLED THE MEETING TO ORDER

The secretary called the roll: Anthony Taliani-present; Rick Stoneburner- not present; Edward Kissel- present; Joseph Novosat- not present; John Nwranski- present.

Jenna Miller & Tim Ruckel – 1020 Parsonage Street Creighton Pa --- Question in concern when the trees that they asked about would be taken out of the creek in their neighborhood from the prior meeting that they attended. Mr. Taliani assured them that we did not forget about the trees and that our summer help has all returned to school and with the bridge replacements going on that they had to move a water line and they have had our guys all tied up at a Mo moment and that we will get the trees out of the creek that we have not forgot about them.

Mr. Taliani mentioned that we would have a Communication from the Pennsylvania Municipal Retirement for the 2019 Municipal Obligation.
