Mr. Taliani asked the wish of the board for Resolution 2020-13 – Concurring Resolution for the Edna Alley Roadway Reconstruction giving designating AVNCOG as the official to fill all applications, documents and forms between East Deer Township and Allegheny County Economic Development. (CDBG Funds \$21,375.00) (local match \$11,150.00) (total cost \$32,885.00). Mr. Nwranski motion to accept Resolution 2020-13, Mr. Stoneburner 2nd the motion. Motion passed unanimously.

Mr. Taliani asked the wish of the board for Resolution 2020-14 - Concurring Resolution for the Grant Street Waterline Replacement giving designating AVNCOG as the official to fill all applications, documents and forms between East Deer Township and Allegheny County Economic Development. (CDBG Funds \$47,716.50) (local match \$25,693.50). Mr. Stoneburner motioned to accept Resolution 2020-14. Mr. Nwranski 2nd the motion. Motion passed unanimously.
