# **COMMUNICATIONS**

Mr. Taliani advised that we received a letter of resignation from part time patrol officer Steven Edwards. It is effective May 21, 2021. He is moving on to a full time position with The City of Duquesne.

Mr. Taliani advised that we received a letter from The Culmerville Modified Softball League asking to use the baseball/softball field at the East Deer Memorial Park during the summer of 2021. That they are in the middle of remolding their field at the American Legion and it is not completed at this time. They have sent the proof of insurance. Mr. Taliani advised that he see no issue in them using it but that we do not maintain it as a baseball field and that they would need to do what they need with the bases and the lines.

Mr. Taliani advised that we have a resolution to entertain this evening, Resolution 2021-04 a resolution for plan review for ne land development – Bailie Plan of Lots. Mr. Taliani advised that this is for Brett and Emily Bailie to be able to start the process of building a new home. It has to do with the sewage/septic on the property. Mr. Taliani asked the wish of the board on resolution 2021-04, Mr. Nwranski motioned to approve resolution 2021-04. Mr. Kissel 2<sup>nd</sup> the motion. Motion passed unanimously.

Mr. Kissel motion to accept resolution 2021-06. Mr. Stoneburner 2<sup>nd</sup> the motion. Motion passes unanimously.

Mr. Taliani advised that we have a resolution to entertain this evening, Resolution 2021-07 a Resolution of the board of commissioners of the Township of East Deer approving that the acquisition and subsequent disposition of numerous parcels of vacant property known as block and lot numbers; 960-j-352 would be in accord with the comprehensive plan of the municipality. Mr. Taliani advised that this property is the old Italian club property. Mr. Taliani asked the wish of the board on resolution 2021-07, Mr. Kissel motioned to accept resolution 2021-05, Mr. Nwranski 2nd the motion. Motion passed unanimously.
