ROLL CALL

The secretary called the roll: Anthony Taliani-present: Rick Stoneburner- not present; Edward Kissel- present by telephone; Joseph Novosat- present; John Nwranski- not present.

MINUTES

The gentlemen asked about the cutting of the weeds and grass on the road then. Mr. Taliani advised that he will have that taken care of with the road crew.

COMMUNICATIONS

Mr. Taliani advised that we received a letter from United Steelworkers 2022-2023 Health Care from the Untied Steelworks 4.15% combined increase for the Medical and Prescription. No increase in other lines of coverage. This increase if you look at what Chrystal has broken down is a substantial. Employee & Spouse went up \$68.80 for medical and prescription went up \$24.02 Individual went up \$25.64 and \$8.74. We will have the contract to approve at next month's meeting.

Mr. Taliani advised that we received a letter Todd Rosio @ Cheswick Christian Academy asking for permission to use the walking track field for the Flag Football again this year for the months of August, September and October. This is the 4th or 5th year of them asking to use the field.

Mr. Taliani advised that we received a letter Dawn Pomaybo Winspirations on using the Memorial Park field for an event in early September, they have not picked a firm date. Mr. Taliani advised that he spoke with Dawn and Winspirations is a non-profit for women. They are looking to do a flea market and use the concession stand. She will provide the copy of insurance.
